

VOLUNTEER RELEASE AND WAIVER FORM

This **VOLUNTEER RELEASE AND WAIVER FORM** is between City Harvest, as defined herein and Volunteer (hereinafter, "I"), and is subject to the following terms:

- (1) **RELEASE AND WAIVER:** In consideration of my participation in volunteer projects and events, I hereby, for myself, my spouse or partner, my heirs, and legal representatives, release and forever discharge, City Harvest and all involved sponsors and their respective agents, employees, officials, directors, and officers (collectively, "City Harvest"), to the fullest extent of the law, from and against any and all claims, demands, liabilities, loss, damage, and causes of action of any sort, including attorney's fees, for any bodily injury, personal injury, illness, death, or property damage incurred by reason of my participation or preparation for the above event, whether or not caused by City Harvest or otherwise.
- (2) **MEDICAL TREATMENT:** I authorize City Harvest to act, in its best judgment, on my behalf in case of emergency, and I do hereby release in accordance with the above RELEASE AND WAIVER, City Harvest from any claim whatsoever which arises on account of any first aid treatment, or medical service rendered to me in connection with the above event.
- (3) **ASSUMPTION OF RISKS:** I understand that my participation in the above event includes work that may involve activities that require frequent bending, lifting, and carrying, contact with fresh produce and food containers, picking and bagging individual food items, cutting and opening food containers using a knife or box-cutter, and working in a crowded environment. I assume all risks of injury or harm from these activities and release City Harvest from all liability for injury, illness, death, or property damage resulting from my participation in the above event.
- (4) **PHOTOGRAPHIC RELEASE:** I also hereby consent to and grant City Harvest permission to reproduce, publish, circulate, copyright, or otherwise use any and all photographs, audio or videotape of me, my likeness and/or my family, for use by City Harvest for advertising, educational, publicity, and trade purposes. The materials may be used indefinitely, and may be used in whole or in part, and in any and all media, including but not limited to publications, television, radio, film, internet, and newspapers, whether now known or hereafter devised. I authorize City Harvest to obtain and hold copyrights in such materials and products, and to edit the materials at its sole discretion.
- (5) **VOLUNTARY SERVICE:** I understand and acknowledge that I may decline any volunteer role or position at any time for any reason. I agree to advise City Harvest of any preexisting conditions that would preclude involvement in any activity.
